EDITORIAL OBJECTIVES

TESTING AND EVALUATION are the essential means for determining relative merit of materials, products, systems, and services. The techniques by which such data are gathered are fundamental to practical engineering and are the vital elements that provide the basis for ASTM's engineering standards.

The objective of this journal is therefore to provide a unique forum for the testing and evaluation field of technology. This journal will continue to be, as was the case for the previous *Journal of Materials*, which it replaces, a forum for presenting data derived from the testing and evaluation of materials, products, and systems of interest to the practicing engineer. Papers will be accepted on the grounds that they present new testing and evaluation techniques, that they provide new information on existing testing and evaluation methodology, or that they contain new data resulting from the testing and evaluation of materials, products, systems, or services.

The importance of engineering standards used in industry, national and international trade, and for the protection of the public, is now universally recognized. Thus, the journal is designed to provide a unique forum for presenting the advances in testing and measurement technology. These advances will enhance the technical validity of engineering standards—the international vocabulary of practical engineering communication.

Contributions are judged on the basis of: (1) the paper contributes to the permanent literature; (2) the paper includes experimental data or mathematical derivations, or both, either as original work or as needed to confirm the theoretical conclusions or proposals; (3) the substance of the paper has not been published in the open literature. Discussions of published papers may be submitted at any time and are also subject to review.

INFORMATION FOR AUTHORS

AUTHORS preparing papers for submittal to the journal should observe the conventions of style explained in the *ASTM Style Manual*. Since the journal does not request page charges, the author is expected to observe these standard conventions for style.
