MEMBERSHIP

- Membership year is 1 January to 31 December. Fees are payable in advance and are not prorated. Membership will become effective upon payment of fees.
- Organizations applying for membership should select one official representative qualified to exercise the rights and privileges of membership. This includes voting on Society Ballot, and if appropriate, on technical committee matters.
- Only the official representative may participate on committees under the organizational membership. All others must maintain individual memberships in order to participate on committees.
- The official representative for the organizational membership may be changed as needed by notifying ASTM Headquarters. Committee participation is not transferable. An application will have to be submitted by the new representative to the appropriate committees. A member not officially serving on ASTM committees may not vote in committee matters.
- For members serving on technical committees, their organizations may ask for this membership to be transferred without payment of additional fees, if the fees were paid by the company. However, no additional free volume of the Book of ASTM Standards will be allowed. Committee participation is not transfer able. An application will have to be submitted by the new member to the ap propriate committee.

- All publications must be shipped to the member.
- Shipping and handling costs will not be charged for prepaid orders shipped to the U.S. and Canada.
