CRIMES OF VIOLENCE: HOMICIDE AND ASSAULT

*Crimes of Violence: Homicide and Assault* is the newest selection in the Criminal Law Library published by The Lawyers Co-operative Publishing Co. and Bancroft-Whitney Co. This reference draws from the strategy and courtroom experiences of its lawyer-authors in some of the most celebrated and controversial cases in recent years—the murder cases of Dr. Samuel Sheppard and Albert DeSalvo, the alleged “Boston Strangler,” and of Captain Ernest L. Medina and Colonel Oran K. Henderson, accused in the My Lai massacre.

The authors use a “how-to-do-it” approach that leads the attorney through each step of a violent crime case from the point of entering the case to final summation. Pretrial investigation is treated in detail, with a procedural checklist and five methods for searching the scene of the crime, information on assemblage of photos and sketches, and preservation of evidence. Separate chapters on footprints, blood, autopsy, and firearms give in-depth treatment to these aspects of case preparation.

Other chapters deal with the elements of violent deaths and of specific violent crimes (culpable homicide, assault, battery, and a full chapter devoted to kidnapping). Chapters treat each step of the trial itself—the preliminary hearing, grand jury proceedings, the indictment, jury selection, opening statements, direct and cross-examination of witnesses, summation and plea negotiations. A final chapter focuses upon participation in the crime and the element of criminal responsibility.

F. Lee Bailey has served as defense counsel in numerous cases of constitutional importance. He achieved national recognition for his successful handling of the Dr. Samuel Sheppard appeal and retrial, and his arguments before the United States Supreme Court helped to set a new standard for the handling of pretrial publicity. Henry B. Rothblatt, of New York City, has been an active criminal lawyer for more than three decades. He is a member of the New York and California Bars and former co-chairman of the Committee on Prosecution and Defense Problems, Criminal Law Section of the American Bar Association, as well as a nationally syndicated columnist. He has handled numerous cases of national prominence.

F. Lee Bailey and Henry B. Rothblatt have co-authored *Investigation and Preparation of Criminal Cases*, *Complete Manual of Criminal Forms*, and other titles in the Criminal Law Library Series.
