#### FOREWORD

The papers appearing in this volume were presented at a Symposium on Corrosion Testing Procedures sponsored jointly by the Society's Committees A-5 on Corrosion of Iron.and Steel and B-3 on Corrosion of Non-Ferrous Metals and Alloys, the purpose of the symposium being to study desirable steps to be taken in the direction of standardization of corrosion testing methods.
