Items excluded from system boundary include:

- production, manufacture and construction of manufacturing capital goods and infrastructure;
- production and manufacture of production equipment, delivery vehicles, and laboratory equipment;
- personnel-related activities (travel, furniture, and office supplies); and
- energy and water use related to company management and sales activities that may be located either within the factory site or at another location.
- No substances with hazardous and toxic properties that pose a concern for human health and/or the environment were identified in the framework of this EPD.

Allocation Procedure

Allocation follows the requirements and guidance of ISO 14044:2006, Clause 4.3.4; and ISO 21930:2017 section 7.2. Recycling and recycled content is modeled using the cut-off rule.

* This EPD meets all comparability requirements stated in ISO 14025:2006. However, differences in certain assumptions, data quality, and variability between LCA data sets may still exist. Life Cycle Inventory

This EPD utilizes foreground LCI data gathered from the participating company's production facilities during the 2025 calendar year. All upstream materials, resources, and energy carriers are modeled using industry-average datasets and published literature, with many datasets defaulted in accordance with the NSF PCR (2021) requirements. * This sub-category PCR recognizes fly ash, silica fume, and granulated blast furnace slag as recovered materials and thus the environmental impacts allocated to these materials are limited to the treatment and transportation required to use as a precast concrete material input.

* Some LCA impact categories and inventory items are still under development and can have high levels of uncertainty. To promote uniform guidance on the data collection, calculation, and reporting of results, the ACLCA methodology (ACLCA 2019) was used.
